

## Rules & Regulations of the Transfer Station

Per Section 118-9 of the Town Refuse Law, permits are required to enter and all residents are required to recycle.

Permits are available at the Town Hall, 24 Jordan Street, or at the Transfer Station for a fee of **\$20.00 per Household**.

Per Section 118-5 All loads must be covered.

Per Section 118-6 Only Refuse that has originated from the Town of Skaneateles will be accepted.

Per section 118-9 Commercial loads and Haulers require a Commercial Permit available at the Town Hall.

**WARNING: Per Section 118-11 Depositing refuse which has not originated in the Town of Skaneateles is punishable by a \$250.00 fine and or 15 days imprisonment.**

All vehicles entering the Transfer Station are required to display a Valid Transfer Station Permit. Any person or company who violates any provision in the rules and regulations could be prohibited from future use of the Transfer Station and may be subject to suspension or revocation of their Transfer Station Permit.

**Your Vehicle Registration may be requested if your address is called into question.**

### Paint days at the Transfer Station:

Resident Permit Holders, only will be allowed to dispose of latex paint and stains at the Transfer Station on the following days:

**August 5, 2017**

**October 7, 2017**

**December 2, 2017**

## RESIDENT PERMIT HOLDERS

### Trash:

*DEPOSIT IN GOLD BUILDING COMPACTOR*

### Garbage:

Place in compactor-clear/white bags only.

### Deposit in designated bins:

- Fluorescent light bulbs
- Car batteries
- Used motor oil

### Recyclables:

*DEPOSIT IN WHITE BUILDING COMPACTOR*

- **Paper.** (YES: newspaper, junk mail, magazines, catalogs, envelopes, office papers, flyers, manila folders, posters, soft covered books, paper towel rolls)
- **Clean non-corrugated boxboard boxes-Please flatten.** (YES: Cracker boxes, pasta boxes, shoe boxes, paper bags, tissue boxes, pizza boxes, cardboard beverage carriers)
- **Empty glass jars & bottles-Clean to remove any residue. Remove lids/tops.** (YES: Food and beverage containers only, can be clear, green, and brown beverage containers)
- **Aluminum cans & clean foil-Clean to remove any residue.** (YES: Empty aerosol cans, food cans, aluminum foil)
- **Containers with recycling code #1 - #7** on the bottom with three recycling arrows; rigid plastic is also acceptable (ex. Items that are stackable and crackable).
- **Paper milk & juice cartons.** (YES: Paper milk, juice cartons, soy milk containers)

## Recyclables (cont.) :

*DEPOSIT OVER WALL IN WHITE BUILDING*

- **\*CLEAN Corrugated cardboard\*-Please flatten all boxes. Remove excess tape and labeling.** (YES: Cardboard with wavy middle layers ONLY)

### What is NOT recyclable in this system?

**NO:** garbage, scrap metal, plastic bags/plastic 6-pack holders, food waste, plastic microwave trays, food-tainted items (used paper plates or boxes, paper towels or paper napkins), polystyrene or styrofoam, window panes, mirrors, ceramics & pyrex dishware, hazardous chemical containers (paint, pesticides, oil & cleansers), electronics or batteries, compact discs or DVDs, foam egg cartons, waxed ice cream cartons, light bulbs, hangers, wax or plastic-coated cardboard, plant containers, medicine or medication bottles, needles or syringes.

**All recyclables have to be emptied from your container or trash bag. Trash bags are to be thrown in the trash. Bags are NOT recyclable.**

See your local grocery stores for recycling your shopping bags.

**St. Pauly:** Used clothing only.

**Swap Shop:** Reusable working items only

## Construction Debris:

Dispose in the opened top containers located in the lower level in the garbage building.

### **SMALL LOADS-Residents Only**

**(one pickup truck load per day)**

This container is for items such as construction lumber, doors, windows, pallets, sheet rock etc.

### Metal Pile Items:

- Washer/ Dryer/ Stove
- Lawn mowers, Bikes
- Lawn Chairs, Metal Pipes
- Gutters, Sheet Metal
- Hot Water Heaters
- Small/Large Kitchen Appliances
- Metal Windows, Pots & Pans
- Anything that is metal

### Compost:

This pile is for lawn waste such as grass, leaves, flowers and plants.

### Brush:

This pile is for items consisting of, branches, bushes and trees (**logs, must be separate from brush**)

### Other Acceptable Items:

- Batteries
- Electronics
- Used cooking oil
- Used antifreeze

**Tires**-Residents Only \***LIMIT** 4 tires per load; **maximum** 12 tires per year
