Town Board Meeting September 15, 2016 6:30 p.m.

Department Reports

•Highway, Transfer Station, Water: Allan Wellington was at his annual Highway School conference. He had reported that they were helping the NYSDOT with milling on Rt. 41A.

•Parks: Sue Murphy reported that they have been busy cleaning up after the Labor Day festivities, lining soccer fields and mowing. She is working on re-establishing her office at the Austin Pavilion after the renovations and working on her budget.

Councilor Badami said he was so impressed how quickly everything was cleaned up after the Labor Day events.

• Fire Department Report: Dana Pickering reported that in August they had 37 calls, 2 structure fires, 11 EMS calls, 2 meetings, 11 drills, and 16 trainings. During the Labor Day weekend they answered 7 alarms, 4 EMS calls, 2 fire alarms and one mutual aid. Engine 21 is scheduled to be completed by the end of November. Tickets are still available for the High Stakes Money Drawing.

Resolution #16-218

<u>Introductory Local Law 2016-C – Revised Abandonment Law</u>: Scott Molnar, acting counsel for this local law stated to the Board that since the last meeting the Town Board declared themselves Lead Agency and referred the local law to SOCPA. SOCPA has determined that "the local law will have no significant adverse inter-community or county-wide implications and may consequently be acted on solely by the referring board." Mr. Molnar said that the Town Board can now move forward with SEQRA process to evaluate the local law and presented the SEQRA resolution to the Town Board for their review. Language has been added to the proposed legislation to manage files open before the Planning and Zoning Boards that predate the prior legislation passed and to clarify what is or isn't effective communication for purposes of an application lying dormant and therefore, abandoned. The resolution is primarily concerning SEQRA reviewing the State law requirements under 6 NYCRR §§ 617.4 and 617.5 identifying that the Town is essentially the only involved agency because this legislation effects only Town Planning and local land use administration. Therefore, it does not affect any other jurisdiction which the Town could ultimately request comment. However, he said that the resolution does acknowledge that the Town Planning and Zoning Boards do have influence and input. As a result of the adoption of the resolution, the Town Board will authorize the Town Clerk to refer SEQRA Part I of the application to the Planning and Zoning Boards for their review and

comment. The Planning and Zoning Boards have already seen this legislation and commented on it and those comments were incorporated into the proposed local law previously. The Planning and Zoning Boards have not seen the SEQRA Application and Part I is the description of proposed legislation. Attorney Molnar recommended that the Town Board review the proposed resolution and advance it for adoption so that the Clerk can refer Part I of the SEQRA application to the Planning and Zoning Boards for their review and comment.

On a motion of Councilor Badami, seconded by Councilor Brace and with unanimous (5-0) affirmation of the Town Board the Town Board adopted the September 15, 2016 resolution as follows:

- 1. The Town Board hereby declares its status and role as lead agency for purposes of the SEQRA of the proposed amendments to the Abandonment Provisions in the Town Code; and
- 2. The Town Board hereby classifies the proposed amendments to the Abandonment Provisions in the Town Code as an Unlisted Action under SEQRA; and
- 3. The Town Board hereby directs the Town Clerk to send Part 1 of the EAF and the proposed amendments to the Abandonment Provision to the interested agencies to request their comments thereon.

Supervisor Lanning said that this legislation would affect three applications.

Discussion on Truck Brakes: Supervisor Lanning said that he has had several complaints about trucks coming into the village using their engine brake so they don't burn out their regular brakes. Doing this is noisy and makes a loud rattling noise. He asked Brody Smith to research the vehicle and traffic law to see if the Town could add additional restrictions.

Councilor Brace questioned if this were more a village issue and that the village has a police department that could enforce additional restrictions and the town doesn't. Supervisor Lanning said he has also had complaints from people on East Lake Road and asked Attorney Smith to research this.

Resolution #16-218

Request for Use of Austin Pavilion: Supervisor Lanning said there has been a request from Kathleen McCarthy to use Austin Pavilion for a Clinton for President fundraiser on October 9th from 1 to 5 p.m. Ms. McCarthy submitted a check in the amount of \$300.

After a lengthy discussion Councilor Howard made a motion seconded by Councilor Badami, to approve a request by Kathleen McCarthy to hold a political fundraiser at Austin Pavilion on October 9th from 1 to 5 p.m.; revising the amount she has to pay to \$260 with the caveat that the only signs allowed for this event are directional signs identifying the location of the rally are permitted. *The request to use the Austin Pavilion was subsequently withdrawn.

Status of Austin Park Transfer: Attorney Smith said that next step is the Village Attorney will file sei pri petition. He received comments today from the Village Attorney. Once he submits his comments on the petition it should be ready to be filed.

Resolution #16-219

Authorize Bronze Plaque – **Conservation Area:** Nancy Murray, a member of the Conservation Committee presented a picture of a plaque with names of the original members of the Conservation Committee. The bronze plaque would be added to a 6,000 pound natural stone to honor the original members of the committee. Ron McDonough, the stone cutter has donated the stone and is only charging for the cement to set the stone. The total cost of the project would be \$1,600.

Bridgett Winkelman said that two quotes were obtained for the plaque. Barnett Memorials was the vendor that was chosen. There is money in the conservation budget.

The Board thanked Nancy and members of the committee for their countless house of dedication to the Conservation Area.

On a motion of Supervisor Lanning, seconded by Councilor Coville and with unanimous (5-0) affirmation of the Town Board the Conservation Committee was authorized to spend up to \$1,600 to add a bronze plaque to the Conservation Area honoring the original members of the committee.
