

Town Board Meeting
January 23, 2020
6:30 p.m.

Present: Supervisor Aaron, Councilor McCormack, Councilor Tucker, Councilor Alexander, Councilor Legg, Attorney Smith.

Also, Present: Mike Major, Bridgett Winkelman, Martin Dillon, Allan Wellington, Dave Matthews, Jerimiah Fleis, Jim Greenfield, Laura Canny, Miranda Robinson.

Highway, Water, Transfer Station: Highway Superintendent Allan Wellington reported the plows had been out 22 times since the last Town Board meeting making that 75 times for the season, compared to 78 times last year to this date. They made multiple truck repairs, picked up fallen trees and limbs due to wind, cut brush along the rights-of-way, patched potholes and finished modifying a V-plow for the loader. He reported in the Water Department they finished the quarterly maintenance on the four pressure reducing valves and removed and serviced a pump at sewer 6 pump station. At the Transfer Station; tags were sold on Saturday, January 11 and he thanked Town Clerk, Julie Stenger and Town Constable, Rick Morris for helping. He reported a geotechnical survey was done at the Transfer Station for the Solar Project and they did some housekeeping and cleaning of the bathroom at the Transfer Station.

Councilor Tucker stated he met with Town in-house engineer; Miranda Robinson and they are working on updating the Water sections of the Town Code and will present to the Board when their review is complete.

Parks: In Parks Manager, Sue Murphy's absence Councilor Alexander reported an Assistant Farmers Market Manager for Saturdays had been established to help manage the Market. They had begun to advertise for Summer staff, playday councilors and lifeguards. She reported there had been communication with the Health Department regarding new requirements for summer camps. Last year measles requirements was new and this year there could be additional items. Sue Murphy met with the contractor at the Sims Building and reviewed the items that need to be completed before the April opening. Rotary had submitted their request for use of the Austin Pavilion for their annual Pancake Breakfast. She reported the Boy Scout Klondike Derby will be on Saturday February 1st at the Austin Pavilion. Councilor Alexander announced; she and Sue will be meeting with Chase Design next week to begin the signage project at the Parks.

Dog Control: Dog Control Dave Wawro gave a summary to the Board of his calls in 2019. He stated he handled a variety of lost/found cats and dogs as well as non-dog/cat calls. He stated although he is not required to handle complaints of animals outside dogs or cats he tries to help when residents call about any animal complaint. He said his average calls for service were about 20 per month or 200 for the year. There was one dangerous dog complaint filed and only one dog seizure for 2019. He had met with the NYS Department of Agriculture and Markets on January 8th for their annual inspection and was found to be in compliance with all requirements.

Officer Wawro stated he was working on a new report to present to the Board monthly to keep them up to date with his activity. He also stated he had researched what other Towns in Onondaga County are doing about the feral cat problem. Most other Towns have a hands-off policy. He would do more research on this and present a more comprehensive approach to dealing with feral cats in the future.

Councilor Legg asked how residents contact him? Officer Wawro stated he is on call 24/7. He has a Town cell phone and the number is posted on the website. Also, it is on the answering machine message at the Town Clerk's office for residents that call after business hours.

Supervisor Aaron thanked Officer Wawro for his report.

Resolution #20-015

Finger Lakes SPCA 2020 Contract: Supervisor Aaron explained to the Board this is an annual contract with the SPCA in Auburn to board dogs and cats picked up in the Town. Supervisor Aaron stated the cost has not increased and they provide a great service to the Town.

On a motion of Councilor Alexander, seconded by Councilor Tucker and with unanimous (5-0) affirmation of the Town Board, the 2020 Finger Lakes SPCA Contract was approved with the same fees as 2019; \$1,600 annual maintenance fee per year and \$9.00 per day per animal for a maximum of 6 days as documented in the contract.

Skaneateles Fire Department: Dana Pickering reviewed the December Chief's report stating there had been 33 calls during December bringing the total to 377 for the year and a total of 807 service hours.

Resolution #20-016

Upstate Fresh Water Institute 2019 Skaneateles Lake and Shotwell Brook Monitoring Report: Supervisor Aaron introduced Dave Matthews from the Upstate Freshwater Institute.

Mr. Matthews reviewed the 2019 monitoring of Skaneateles Lake and Shotwell Brook. He stated their monitoring objectives were to establish prevailing water quality conditions of the lake and its tributaries, to update historic water quality records with continuing monitoring and to collect data to support the future development of the 9-element management plan and water quality model.

Mr. Matthews explained to the Board the Skaneateles Lake Watershed is 36% agriculture, 34% forest and 6% undeveloped. The Upstate Fresh Water Institute had been monitoring the lake since 2007. Over these years a variety of data has been collected.

Mr. Matthews explained, although there were some differences between certain metrics, there has generally been little change in the overall water quality of the lake. The 2019 summer average concentrations of chlorophyll-a were higher than concentrations measured in previous years, Secchi Disk (used to measure water transparency or turbidity in bodies of water) depth and total phosphorus were lower. However, these common metrics of trophic state continue to remain within the accepted ranges for oligotrophic lakes, such as Skaneateles Lake. He stated the water clarity of the lake had been consistently high, the Fluoroprobe (measuring instrument for the analysis of

chlorophyll with algae class determination) identified the presence of cyanobacteria in September, but were low in concentration, microcystins were not detected and phosphorus releasing from sediments is unlikely.

Mr. Matthews reviewed the monitoring of Shotwell Brook. He stated Shotwell Brook is approximately 3 kilometers south-southeast of the Village of Skaneateles and approximately 1.5 kilometers southeast of the drinking water intake pipes. Shotwell Brook is 5.6% of the Skaneateles Lake watershed area and is 64% agricultural and 20% forested. Shotwell Brook is a known source of turbidity to the lake, especially during high flow (intense rainfall and snow melt).

Mr. Matthews explained the Upstate Freshwater Institute had monitored Shotwell Brook and Skaneateles Lake well before the Harmful Algal Blooms which had given us a good baseline for our testing. They had developed estimates of streamflow, characterized water quality at high intervals for temperature, conductance and turbidity and to describe water quality during different flow conditions.

Mr. Matthews stated Shotwell Brook is a relatively small stream and is expected to have generally low streamflow. In 2019 the median flow was higher than observed in previous years, 2019 was wetter than the long-term average, which most likely contributed to the overall higher flow.

Mr. Matthews reviewed the future monitoring for 2020. He stated in 2020 they will start Winter and Spring monitoring of the streams with the Town. These streams will include not only Shotwell Brook, but One Mile Creek, Snow Brook and Harold Brook.

Supervisor Aaron asked Mr. Matthews if the monitoring on the lake and its tributaries by the different agencies, such as the NYS DEC, City of Syracuse and Onondaga County are coordinating with each other for their testing and data. Mr. Matthews stated some of the information and data are coordinated by Amy Klinkhammer at the Finger Lakes Hub.

Councilor Legg asked if any coordination was specified in the 9-Element Plan. Mr. Matthews stated no, it is the responsibility of each agency to coordinate their data.

Supervisor Aaron stated when Zebra Mussels were beginning to inhabit the lake, the clarity of the water improved. What role do Zebra Mussels play in the Harmful Algal Blooms? Mr. Matthews answered Zebra Mussels and the more harmful Quagga Mussels which were originally only around the shoreline have spread through the lake. He said he had seen them at the bottom of 200' of water. He stated these mussels are filter feeders, they filter out what they do not like. These mussels do not like microcystins, therefore they filter them out and therefore create the more likely hood of a Harmful Algal Bloom. Mr. Matthews said lakes with a population of Zebra and Quagga Mussels have a higher increase for Harmful Algal Blooms.

Councilor Legg asked Mr. Matthews if the monitoring at Shotwell Brook is at a single point? Mr. Matthews stated yes, they have a single point monitoring system as far upstream as they can, they will likely place monitoring sites downstream in 2020 for additional data to compare.

Supervisor Aaron thanked Mr. Matthews for his presentation.

Minutes of January 6, 2020: On a motion of Councilor Legg, seconded by Councilor

McCormack, and with a (5-0) affirmation of the Town Board the minutes of January 6, 2020 were accepted as presented.

Resolution #20-018

Insero & Co 2019 Town Audit Proposal: Budget Officer Bridgett Winkelman reviewed the proposal from Insero & Co to complete the Town of Skaneateles 2019 audit. She stated the proposal completes all the filing as required by the law. The proposal is at a cost not to exceed \$10,700 for the Town audit, \$1,200 for the AUD filing, \$1,000 for the Town Clerk audit and \$1,100 for the Justice Court audit, for a total of \$14,000. This cost is currently in the approved 2020 budget.

On a motion of Councilor McCormack, seconded by Councilor Legg and with unanimous (5-0) affirmation of the Town Board, the proposal from Insero & Co was approved by the Town Board for the 2019 Town Audit not to exceed a total \$14,000.

Resolution #20-019

Introductory Local Law A of 2020- “A Local Law Regarding the Date for The Board of Assessment Review to meet and to hear complaints regarding Real Property Tax Assessments in the Town”: Supervisor Aaron explained to the Board, the Town Assessor had requested to move the Town of Skaneateles Grievance Day back to the 4th Tuesday of May. The Town Assessor requested Grievance Day be moved to June to accommodate their schedule, since they were the Assessor in other Towns. Town Assessor Mike Maxwell is now requesting to move Grievance Day back to the fourth Tuesday in May, as it had been for many years.

Supervisor Aaron stated “the requirements of NYS law are that Towns set a date for the Board of Assessment Review to hear complaints from taxpayers in relation to real property assessments, and to set that date for the Town’s Board of Assessment Review to meet to hear complaints in relation to real property assessments in the Town.”

On a motion of Councilor Tucker, seconded by Councilor Alexander and with unanimous (5-0) affirmation of the Town Board, the Town Board authorized a Public Hearing to be held before the Town Board of the Town of Skaneateles of New York, at Town Hall, 24 Jordan Road, Skaneateles, New York, on the 20th of February, 2020 at 7:00 p.m. concerning proposed Local Law No. 2020-A, entitled “A Local Law Regarding the Date for the Board of Assessment Review to meet and to hear complaints regarding Real Property Tax Assessments in the Town.”

Resolution #20-020

Town of Skaneateles Fire Protection District – 2020 Percent of Equipment Allocation: Supervisor Aaron explained the Town used to approve the contract with the Village for Fire Protection yearly, last year this contract was changed to a 5-year contract. The Board needs to approve the percentage of funds that will go directly to the Fire Department for equipment allocation each year.

Budget Officer Winkelman stated this equipment allocation was approved in the Town’s 2020 Budget for a 35% allocation of the 2020 budgeted funds be allocated for equipment expense.

On a motion of Councilor Legg, seconded by Councilor Tucker and with unanimous (5-0) affirmation of the Town Board, the Town Board authorized the allocation of 35% of the 2020 budgeted amount of \$301,785.73 for the Skaneateles Fire Department District for equipment in the amount of \$105,625.01.

Resolution #20-021

Establish Escrow Account – Talcott Water District: Supervisor Aaron stated the request to form the Talcott Water District should be submitted to the Board at the next meeting. In order to proceed with this request an escrow account will need to be established.

Attorney Smith and the Town Board agreed that an escrow account for the Talcott Water District in the amount of \$5,000 should be established for any legal or engineering fees required by the Town. Attorney Smith stated the bulk of the work will be creating and filing easements for the proposed water line.

On a motion of Councilor Tucker, seconded by Councilor Legg and with unanimous (5-0) affirmation of the Town Board, the Town Board authorized to establish an escrow account in the amount of \$5,000 for the Talcott Water District for any legal or engineering fees required by the Town.

Resolution #20-022

Town of Skaneateles Route 20 Corridor Committee: Supervisor Aaron stated the Town is proposing the establishment of a committee for the Town of Skaneateles Route 20 Corridor Revitalization. She stated there is the possibility of grants and funding from the NYS Department of Transportation for corridor project like ours. She stated the NYS Department of Transportation is scheduling a paving project along this section of Route 20. With this project there might be an opportunity to incorporate some updates and changes to the entrances to the Town along Route 20 East and West.

Councilor Legg asked if there will be a term for these committee members, and could other people be appointed to this committee? He stated he knew of a few residents that are interested. Supervisor Aaron said no, there is no term limit for the members and if there are other residents who would like to join, she would be in full support of additional members.

On a motion of Councilor Tucker, seconded by Councilor Legg and with unanimous (5-0) affirmation of the Town Board, the Town Board authorized to establish the Town of Skaneateles Route 20 Corridor Committee with members: Scott Winkelman, Town Planning Board Member , Karen Barkdull, Town Planning Clerk, Howard Brodsky, Town Planner, Marty Cregg, Chase

Design, Mark Tucker, Town Board Member and Kevin McCormack, Town Board Liaison to the Route 20 Corridor Committee.

Resolution #20-023

Authorize Transfers from Reserve Funds: Supervisor Aaron stated to the Board, Budget Officer Bridgett Winkelman had presented the reserve fund transfers that were budgeted in the 2020 Town of Skaneateles Budget. She explained money transferred from a reserve fund is subject to the permissive referendum requirements of Town Law and General Municipal Law and must be posted and advertised for 30 days prior to the transfer.

On a motion of Councilor Tucker, seconded by Councilor McCormack and with unanimous (5-0) affirmation of the Town Board, the Clerk was instructed to advertise to transfer from the following funds subject to the permissive referendum requirements of Town Law:

From the Bridge repair Reserve Fund an amount not more than \$20,500; \$16,500 to purchase aluminum culverts and headwalls and \$4,000 to purchase fill rock.

From the Highway Equipment Reserve Fund an amount not more than \$93,072; \$4,427 to purchase a pickup broom for a skid-steer, \$19,674 to purchase a milling head for a skid-steer, \$3,931 to purchase a walk behind compactor, \$40,041 to purchase a mowing tractor and \$25,000 to purchase a ½ ton 4x4 pickup truck.

From the Highway Building Capitol Improvement Reserve Fund an amount not more than \$30,000; \$26,000 for a concrete floor and \$4,000 for interior walls in the pole barn.

From the Transfer station Equipment Reserve Fund an amount not more than \$21,000 to purchase a self-contained garbage compactor.

From the General Recreation Reserve Fund an amount no more than \$45,100; \$9,000 for bleachers, \$1,500 for benches, \$2,000 for picnic tables, \$8,000 for ball mix on fields, \$6,500 to purchase a Ferris mower, \$3,000 for a small John Deere, \$1,500 for a battery- Gator, \$3,000 for tree service and removal, \$5,000 for fence repair, \$5,000 for sand.

From the Charlie Major Nature Trail Reserve Fund an amount no more than \$4,000 for bridge repair.

From the Town Hall Office Equipment Reserve fund an amount no more than \$18,000 for computers and server upgrade.

From the Tax Stabilization – Fire district Reserve Fund an amount no more than \$101,550 for the Town’s portion of the air packs purchased by the Skaneateles Fire Department.



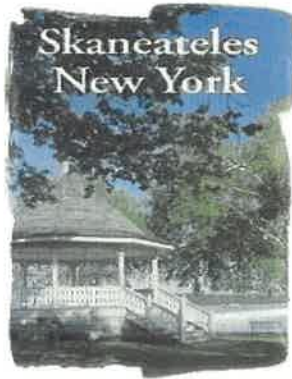

My low month was January with 8 calls for service, too a high in the month of July with 35 calls for service. My average calls of service range mostly around approximately 20 calls of service per month, or between approximately 200 – 250 calls for Service.

I handled one serious dog bite complaint, which I ultimately wrote up as a Dangerous Dog Complaint and sent the Animal Owners to Court. I had only 1 Dog Seizure in 2019 where I took the dog to the SPCA in Auburn; Down from 8 Seizures in 2018 and 4 in 2017.

On January 8th, 2020, I meet with Paulina Renggli with the New York State Department of Agriculture & Markets and received my Annual Inspection and Evaluation and was found to be compliant with all requirements.

Moving ahead, I intend to be more diligent and provide monthly activity reports to the Board. I am currently working on a new activity/run sheet which I will complete after each call for service and include them as part of my monthly reports.

Feral cats were Still an issue, but far less than in 2018. I am currently working with the Town of Van Burren Animal Control Officer to establish a more comprehensive approach when dealing with Feral cat Complaint.

I am very grateful to be serving our Community and I take my position as Animal Control very Seriously. I just want to take this time to thank Supervisor Aaron and the entire Board for having confidence in my ability to get the job done.







Be it enacted by the Town Board of the Town of Skaneateles as follows:

Section 1. Title

This local law shall be referred to as "Local Law Regarding the Date for the Board of Assessment Review to meet and to hear complaints regarding Real Property Tax Assessments in the Town".

Section 2. Purpose and Intent

This local law is intended to comply with the requirements of New York State law that Towns set a date for the Board of Assessment Review to hear complaints from taxpayers in relation to real property assessments, and to set that date for the Town's Board of Assessment Review to meet to hear complaints in relation to real property assessments in the Town as the fourth Tuesday in the month of May, commencing during calendar year 2020 pursuant to New York Real Property Tax Law Section 512 (1-a).

Section 3. Legislative Findings

The Board finds that the fourth Tuesday is an appropriate time for the Board of Assessment Review to hear complaints in relation to assessments of real property in the Town, and convenient to the schedule of the Assessor, who is also employed as an assessor by other assessing units.

Section 4.

The invalidity of any provision of this Local Law shall not affect the validity of any other provision of this Local Law that can be given effect without such invalid provision.

Section 5.

This local law shall take effect immediately upon filing in the Office of the Secretary.
