Department Reports:

Highway, Transfer Station, Water: Jim Card gave his last report as Highway Superintendent before retiring saying that all departments were operating as usual. They have been plowing and sanding. New containers were delivered at the Transfer Station and are being used. One more container needs fabricating before being put into operation.

Parks: Sue Murphy said that many private groups are renting ice over the holidays. With the 50 degree weather this weekend it may be a challenge with the moisture and dripping from the roof. She thanked the Town Board for all the support she has received from them and especially thanked Steve McGlynn for always answering his phone whenever there was a call from the Parks Department.

Outreach, Conservation, Historian, Cemeteries, Town Hall: Councilor Murray said that Outreach has helped over 30 families with Christmas this year.

Codes: Debbie Williams reported that the new Codes Enforcement Officer, Adam Damico resigned last Friday. In 2011 he took a Civil Service test for a job that just became available in Syracuse and the offer was too good to refuse. Ms. Williams said that she has been asked to stay on but she declined. She will be using some of her vacation time so her last day will be December 26th. She thanked the Town Board and said she really felt the support from this Town Board.

Budget: Bridgett Winkelman reported that Cuddy & Ward started their preliminary audit by looking at reports from the various departments. They will be back in February 2014. The new server will be installed next week. She thanked the Town Board for their support and everything they accomplished.

Special Individual Presentations:

▪**Recognition of Jim Card** – Jim Buff and Eric Sell recognized Jim Card and thanked him and said the fire department very much appreciated all he had done for the fire department during field days, keeping the roads clear and safe and for the many times they supported their fire calls. Jim Buff also thanked Councilor McGlynn and Councilor Keyes for all their support of the fire department

Presentation to Terri Roney – Jim Buff and Eric Sell, presented to Supervisor Roney on behalf of the Skaneateles Fire Department a clock with an inscription thanking her for her support of the fire department and her years of service to the Town of Skaneateles.

Presentation to Debbie Williams – Supervisor Roney recognized and thanked Debbie Williams who is retiring at the end of December after 22 years of service to the Town as Codes Enforcement Officer. She said that Debbie was a key person in helping to draft the first Joint Town and Village Comprehensive Plan adopted in 1996 and she witnessed first-hand the development that was beginning to take place, especially in the watershed, and knew that a more restrictive ordinance was the only way to help prevent over development. Supervisor Roney said that Debbie knew this would make her job more difficult and open her up to criticism because not all people would be happy about the more restrictive rules. She said Debbie would be missed but she has left a big imprint on the heart of our Town's development for which we should all be grateful to her.

Presentation to Jim Card: Councilor Greenfield said he has known Jim Card for many years. They were high school classmates and that he has seen Jim Card more than any other classmate since graduation. He presented Jim, who's moving to North Carolina, with a toy dump truck converted to be a snowplow with a plastic beach shovel attached to the front and wings on the side. Councilor Greenfield said that with global warming Jim should be prepared for snow in North Carolina. He also presented to Jim Card a clock engraved with appreciation and thanks for Mr. Card's 32 years of service to the Town of Skaneateles.

Presentation to Councilor Keyes: Councilor Nancy Murray paid tribute to Rick Keyes with a poem that she wrote saying at the end that from an Irish girl, "the luck of the Irish is with you". She presented Councilor Keyes with a clock engraved with appreciation and thanks for his 4 years of service to the Town of Skaneateles.

Presentation to Councilor McGlynn: Janet Aaron paid tribute to Steve McGlynn stating that Steve served on the Planning Board before being elected as Councilor in 2009. She said Steve is the youngest Board member she worked with and he reminded her what it is like to be young and have all that energy. Steve never lacked for ideas and she said she found it hard at first keeping up with him, but over the years she said that even though his thought process was 100 times faster than hers she realized just how passionate he was and how much he cared not only about the people of this community but the employees and officials of the Town. She thanked him for the support he gave her and his fellow Board members, department heads, staff and employees of the Town. She said he did make a difference. Councilor McGlynn was presented a clock thanking him for his years of service to the Town.



She ended by thanking her for her support and saying that the Town may be losing a Supervisor but we gained a friend. She presented Supervisor Roney with a Christmas centerpiece.

Supervisor Roney thanked her fellow board members and everyone, saying that they have been fabulous to work with. She said it has been a pleasure working with everyone and getting to know and becoming friends with so many. She said this is like a family and said it was a great ride for 4 years.

Councilor McGlynn said that 4 years ago he really had no idea how much work our Town employees do and said they should be thanked on a regular basis.
